Washington State Law RCW 68.50.160 states, in part, that a person has the right to control the disposition of his or her remains without the consent of another person. Prearrangements that are prepaid or filed with a licensed funeral establishment are not subject to cancellation or substantial revision by survivors.

The statute also goes on to say that if the decedent has not made a prearrangement or directions have not been given by the decedent, the right to control the disposition vests in, and the duty of disposition and liability for the reasonable cost of preparation, care and disposition of such remains devolves In the order named:

- I. Surviving Spouse
- 2. Surviving Adult Children
- 3. Surviving Parents
- 4. Surviving Brothers and Sisters
- 5. Person acting as a representative of the decedent under the signed authorization of the decedent. (Power of Attorney ends at death.)






#### **Kecia Murphey**
